Conditions of Membership

1. Bring a **photocopy of current vaccinations and rabies certificate for Rover's Ranch to keep** on file. These shall be presented with the membership application **on or before the 1st time you use the park**.
2. Members must be age 18 or older and agree to abide by all Rover's Ranch Rules. Each handler may have 2 dogs in the park at one time. Each dog must be listed on your membership.

Hold Harmless Waiver
